

## NOTICE TO BIDDERS

Sealed bids will be received in the Office of the Ottawa County Clerk, Reba G. Sill, at 102 East Central Avenue, Suite 103 in Miami, Oklahoma 74354 until 9:05 AM on June 25, 2012. Bids will then be opened and read aloud by the Ottawa County Board of Commissioners on the following:

### STANDARD CARBON DOUBLE-BEVEL CURVED GRADER BLADES FOR THE PERIOD JULY 1, 2012 THROUGH DECEMBER 31, 2012

All grader blades must meet or exceed the following specifications:

#### Chemical composition limits (%)

Carbon	0.80 to 0.93
Manganese	0.60 to 0.90
Phosphorus	0.04 maximum
Sulphur	0.05 maximum
Silicon	0.15 to 0.30

Diameter of Brinell indentation: 3.80 to 3.38 millimeters

Hardness properties for standard carbon blades

Brinell hardness: 10mm ball; 3,000kg load: 250 to 325

Rockwell hardness C-Scale: 25.4 to 34.7

Bolt holes shall conform with the Society of Automotive Engineers Specification No. J-740 for countersunk square holes for cutting edges

Holes shall be spaced very accurately on a straight line and be located within 1/16" of the dimensioned position using both end holes as datum points

Bids submitted must be clearly marked on the outside of a sealed envelope:

Firm prices will be FOB Ottawa County.

Purchases by Ottawa County, Oklahoma are not subject to State or Federal taxes.

This bid is submitted as legal offer and any bid, when accepted by the County, constitutes a firm contract.

Oklahoma laws require each vendor submitting a bid to a County for goods or services to furnish a notarized sworn Statement of Non-Collusion (**form supplied below**).
