Sealed bids will be received in the Office of the Ottawa County Clerk, Reba G. Sill, at 102 East Central Avenue, Suite 103 in Miami, Oklahoma 74354, until 9:10 AM on June 30, 2014. Bids will then be publicly opened and read aloud by the Board of County Commissioners on the following:

### 1993 OR NEWER USED 10-WHEEL DUMP TRUCKS

One or more fully-serviced and operational unit in good condition which meets or exceeds the following minimum specifications:

- 1993 or newer used 10-wheel dump truck
- Minimum 300 horsepower
- 9, 10 or 13-speed transmission or equal
- Minimum 38,000 pound spring or air ride
- 12,000 minimum pound front axle weight
- Rear differential lock
- Air conditioning
- Minimum 14' dump bed with hydraulics
