Sealed bids will be received in the Office of the Ottawa County Clerk, Reba G. Sill, at 102 East Central Avenue, Suite 103 in Miami, Oklahoma 74354, until 9:05 AM on August 11, 2014. Bids will then be publicly opened and read aloud by the Board of County Commissioners on the following:

USED PURSUIT VEHICLES

The Ottawa County Sheriff's Department is seeking competitive Bids for two or more vehicles which meet or exceed the following minimum specifications for full-size police pursuit automobiles:

- 2011 or newer with a maximum of 55,000 miles
- Four door, post type sedan
- Prefer dark blue (please state color available)**
- Automatic transmission
- Auxiliary interior lights
- Bucket seats
- Tilt steering wheel
- Cruise control
- Air conditioning
- Rear window defrost
- Power windows and door locks

Vehicles must be used (**not rebuilt**), in sound mechanical condition with **less than 55,000 miles** and subject to inspection by the Ottawa County Sheriff's Department.

Units must be available for pick up within fifteen (15) business days after vendor notification of Award of Bid.

This Bid is submitted as legal offer and any Bid, when accepted by the County, constitutes a firm Contract.

Oklahoma laws require each Vendor submitting a Bid to a County for goods or services to furnish a notarized sworn Statement of Non-Collusion (**form supplied below**).

NOTE: Other terms and conditions may be added at the discretion of County Officers.
