

NOTICE TO BIDDERS

Sealed bids will be received in the Office of the Ottawa County Clerk, Reba G. Sill, at 102 East Central Avenue, Suite 103 in Miami, Oklahoma 74354, until 9:05 AM on August 31, 2015. Bids will then be publicly opened and read aloud by the Board of County Commissioners on the following:

SOUTH 705 ROAD PAVING PROJECT

PROJECT: Paving approximately 1.7 miles with a 2.5" Type B compacted asphalt overlay @ 20 ft wide

LOCATION: Beginning at Warren Branch Bridge on South 705 Road, then south to Iris Road, which is just south of East 60 Road

Contractor is to provide, haul, lay and roll asphalt with tack oil. Additionally, contractor is to provide all traffic control.

Bid MUST include estimated total tonnage and price per ton laid in place.

All work performed must meet Oklahoma Department of Transportation specifications, under the direction of Ottawa County Commissioner John Clarke. Mr. Clarke may be reached by contacting Highway District 1 Maintenance Facility @ 918-673-1100.

All material used must meet current Oklahoma Department of Transportation specifications, with Mix-Design to be submitted by the successful Bidder at least ten (10) days prior to beginning Project.

Prospective Bidders are **required** to attend a **Pre-Bid Conference** at 9:00 AM on Tuesday, August 25, 2015, which will be held at the intersection of South 705 Road and East 50 Road.

This Bid is submitted as legal offer and any Bid, when accepted by the County, constitutes a firm Contract.

Oklahoma laws require each vendor submitting a Bid to a County for goods or services to furnish a notarized sworn Statement of Non-Collusion (form supplied below).

STATEMENT OF NON-COLLUSION
