

NOTICE TO BIDDERS

Sealed bids will be received in the Office of the Ottawa County Clerk, Robyn Mitchell, at 102 East Central Avenue, Suite 103 in Miami, Oklahoma 74354 until 9:05 AM on June 20th, 2023. Bids will then be opened and read aloud by the Ottawa County Board of Commissioners on the following:

OTTAWA COUNTY FARMLAND *FOR THE PERIOD JULY 1ST, 2023 THROUGH JUNE 30TH, 2024*

Lease of approximately 24 acres of cropland

This county-owned property is located approximately 2.5 miles southwest of Miami, Oklahoma.

A portion of said land may be withdrawn from the leasehold by the Board of County Commissioners at any time. The withdrawal provision shall apply only if:

1. The County Commissioners shall give the tenant at least 30 days written notice of the intention to withdraw said land
2. In the event the withdrawal affects crops not yet harvested or pasture which is not yet cut, so as to deny the tenant the intended use of said acreage, the County Commissioners shall reimburse the tenant any prepaid rent for those acres withdrawn
3. If more than 10 acres are withdrawn the tenant may, at their discretion, cancel the lease by giving 30 days written notice.

Bids submitted must be clearly marked on the outside of a sealed envelope:

and must be accompanied by a completed and notarized "Statement of Non-Collusion" as required by O.S. 74, Section 85.22.

The Board of County Commissioners reserves the right to reject any or all bids and/or make an award to other than the high bidder if such an award is deemed to be in the County's best interest.

Firm prices will be FOB Ottawa County.

Purchases by Ottawa County, Oklahoma are not subject to State or Federal taxes.

This bid is submitted as legal offer and any bid, when accepted by the County, constitutes a firm contract.

Oklahoma laws require each vendor submitting a bid to a County for goods or services to furnish a notarized sworn Statement of Non-Collusion (form supplied below).

NOTE: Other terms and conditions may be added at the discretion of county officers.

STATEMENT OF NON-COLLUSION
