- 5. Citizens participation or comments: Rick Aldridge, president of the Oklahoma Emergency Response Team, announced the SEK Clinic (behind Braums in Miami) along with Integris, and the Health Department will administer doses of the COVID vaccine. They are set and ready to go and costs nothing to the County. To schedule your appointment please call 866.888.8650, or you may go to the SEK clinic, or the Good Neighbor Project page on FB to preschedule. They feel there will be enough vaccines for everyone in the County and surrounding areas that desire to be inoculated. Mr. Aldridge also stated the Good Neighbor Project, along with the County, and the City of Miami will be partnering for the City spring cleanup which begins on March 22<sup>nd</sup>. Commissioner Chasteen thanked Mr. Aldridge for all the good work he does within Ottawa County.
- 6. Covid-19 update: No action to modify current policies although Commissioner Chasteen along with the other commissioners hope to open the courthouse within the next 30-90 days, depending on the continuous drop in cases or when the majority of citizens are vaccinated.
- 7. Motion by Chasteen, second by Earls, to approve a 6% increase in raise (which were tabled on March 2<sup>nd</sup>) for Ottawa County Employees, and included it to be retroactive from January 1, 2021. By vote: Earls, aye; Chasteen, aye; Furnas, aye.

- 8. Motion by Furnas, second by Earls, to approve authorization for district 3 to solicit competitive bids for one or more vehicles/pickups. The motion also approved district 1 and district 2 to be included. Confirmed by Kenny Wright, D.A. By vote: Chasteen, aye; Furnas, aye; Earls, aye.
- 9. Motion by Chasteen, second by Furnas, to approve the donation of four Panasonic Toughbook laptop computers with vehicle mounts to the Ottawa County Sheriff's Office for law enforcement purposes from the Miami Tribe of Oklahoma. By vote: Earls, aye; Chasteen, aye; Furnas, aye.
- 10. Motion by Earls, second by Furnas, to approve a Service Agreement between Guy Engineering Services, Inc. and the Ottawa County Commissioners. By vote: Furnas, aye; Chasteen, aye; Earls, aye.
- 11. Motion by Furnas, second by Earls, to table contract between the Oklahoma Turnpike Authority and the Ottawa County Sheriff's Department to assign inmates to perform roadside work. By vote: Chasteen, aye; Furnas, aye; Earls, aye.
- 12. Motion by Chasteen, second by Earls, to approve contract for fiscal year 2021-2022 between the Sac and Fox Nation Juvenile Detention Center and the Board of County Commissioners of Ottawa County. By vote: Earls, aye; Furnas, aye; Chasteen, aye.
- 13. Motion by Chasteen, second by Earls, to enter into Executive Session for the purpose of confidential communication between the Board of County Commissioners, Elected Officials, and Kenny Wright, D.A. to discuss salaries of elected officials. By vote: Earls, aye; Chasteen, aye; Furnas, aye.
- Motion by Furnas, second by Chasteen, to adjourn from Executive Session and return to regular meeting to vote on an increase in salaries for elected officials. With a formula from the SAI and County Assessor's office reflecting population, taxable value, additional homestead, county mill rate, and service-ability with a maximum base salary of \$44,500 along with the County's general ledger for money available, an increase in pay was justified from a yearly salary of \$48638.76 to \$53500.00, which is still lower than the max allowed. A survey of other surrounding counties, (ten to be exact) showed Ottawa officials ranked number 9 as the lowest paid. Some counties had much lower populations than Ottawa. The raise increase has put salaries of Ottawa County official's number 6 on the list. The raise will reflect on March's payroll. It was agreed by all official's, no retroactive pay would be put in place. By vote: Chasteen, aye; Furnas, aye; Earls, aye.
- 21. Commissioners' activity reports. District 1: Keeping roads passable. ODOT has installed signage to prevent accidents on roads. The county and city are working on illuminated signage, light or flashing lights for other roads for safety reasons. Routine Maintenance. District 2: Commissioner Chasteen and crew did a storm assessment on damage with an app. Which added up to over 300K in asphalt damage alone during the ice/snow storm, and are waiting on answers from FEMA. The crew is busy on the roads trying to make them safe for the public. A big thanks to district 3 for their help recently. District 3: Routine maintenance, working on future projects, and continuous road work.
