- 8. Motion by Earls, second by Furnas, to approve CED#1 (Circuit Engineering District) Materials Request Grant Application for Ottawa County District #2 to construct a reinforced concrete box bridge on 705 Road just north of State Highway 10C. By vote: Masterson, aye; Furnas, aye; Earls, aye.
