20. Commissioners' report. District #1: Commissioner Furnas reported on the ground breaking with the Quapaw Nation for the call center. Furnas hopes to keep open the convenience center but reminds the public it is not a sanitation service for businesses. His district is working on roads ways for inspection. Routine maintenance. District #2: Commissioner Chasteen reported on road maintenance. They will be working in zones 1, 2, 5, and 6. Asphalt patching plans, and two overlay plans for next year. A reminder that the sanitation service is open Monday-Thursday from 8 a.m. until 4 p.m., or until there is no room left. Signage and cameras will be installed. Chasteen will also be working on a project list for the remaining of the year. He praised the 4-H/FFA youth for their services in hauling hay. In return Commissioner Chasteen will donate half a beef for fair time for a fund raiser for the youth. District #3: Commissioner Earls was also at the call center ground breaking ceremony along with Furnas and Sheriff Dean. Sheriff Dean will be giving \$100,000 out of his budget to help with the call center. Earls also thanked the tribes for making this possible. It should take at least 7 months to complete. Earls requested Chad Holcomb, Emergency Manager help find a vehicle to share between the districts and the County's IT manager, Dalton Hilton. Sheriff Dean interjected he would like to thank Tyler Cline, City of Miami for helping find the water leak in the jail. Dean's comment was, "he saved our tails".
