- 18. Commissioners' activity reports. District #1: The crew came in over the weekend to post road closures signs due to flooding. Neosho River is supposed to be back in its banks this evening or later in the week. We are trying to hold all of the soft spots together. Tar Creek bridge between 30 road and 69 is now open to a 6-ton limit. The Health department is still taking appointments for the COVID-19 testing. District #2: We also got called out over the weekend. A few trees were down. We had to shut a road down for a short amount of time until the water got off of it but it is now open. Working on roads all last week and we will continue to work on them. Bridge over 128 road is now open with a guardrail. It turned out very well and it really helped out that area. Received an email from Debbie Dry from the Wyandotte Tribe about the Wyandotte Ridge Road that we discussed a couple of weeks ago. She sent blueprints on the road that they built. There was 6" of base and 4" of asphalt put on those roads which meets our standards. Routine maintenance. District #3: Routine maintenance. Bridge on 600 road between 210 and 200 was finished last week and opened with guard rail. That is a heavily traveled road. I want to thank our legislators for supporting and backing our CIRB bill which puts 42 million dollars back in county government statewide which amounts to \$421,000 locally. With the COVID-19 we have been left out of the stimulus packages so we worked with our legislators to support bill 1888 and in the final hours was able to help get this passed. There was a cost of living increase to all county retired employees included in this as well as a self-funded hazard duty for retired deputies.
