- 5. Update on the COVID-19 situation presented by Maria Alexander from the Oklahoma Department of Health. There have been over 6000 cases in Oklahoma with overwhelmingly most of those cases have recovered. In Ottawa County there are 8 cases with 0 deaths in the long-term health

facilities. Every long-term health facility has been tested. Even though Ottawa County has been doing very well, precautions still need to be taken. Continue to be vigilant with social distancing, washing your hands, and wearing your mask in public. Masterson asked if the number of people being tested has lessened. Maria said when there is a positive case verified, the testing does increase. Ottawa has remained consistent with 10 to 15 being tested each day. We are not doing the antibody test yet, but there has been quite a bit of talk to start this test in select health departments. This testing is strictly used for a baseline to see how prevalent COVID-19 was during the season. We are not sure which counties will be selected for this testing. Maria also announced her retirement at the end of the year.

- 19. Commissioners' activity reports: District #1: Road closures due to flooding. Thanks to the Quapaw Nation for helping us on roads. We will continue to drain roads and get materials on them. We are continuing to try to do that economically. Thanks to the citizens that call in and give reports on the roads. District #2: Crews are out to clear trees in roads. Trying to figure out which roads to close due to

flooding. Thanks to District #1 for helping out on the road 137 ditch project. Routine maintenance. District #3: Routine maintenance and FEMA remediation. We will be getting \$421,000 locally for our share on Bill 1888, thanks to the legislature. This can be used on overlays. Always a good thing to put projects on the shelf in case there are additional funds coming up in the future. There is a Cost of Living Increase for retired county employees of 4% starting July 1. On Bill 1403, which requires our State Auditors to start auditing our Circuit Engineering Districts, we've always been audited per the legislature, wants the auditor and inspectors to do this. It may be cheaper for the CED's. We need to continue to talk about our insurance pools. We have 20 counties that are in the pool and 10 of those are jeopardizing the stability of the pool. Ottawa County is one of those. Most of this comes out of the Sheriff's departments. We have gone to \$10,000 deductible to \$25,000 and coverage is lowered from 2 million to 1 million. It will take 3-5 years to get out of this and only if we manage to do everything right and if we can convince the Sheriff to submit his operation, his plan on how he runs the jail and get it updated manually. These manuals will get any jail through a situation where we have lawsuits. This goes for warehouse districts as well. Keep our people trained, safe, and do anything we can to keep this premium down.

- 20. In new business, Kathy Enyart asked when the courthouse would be opening up to the public. The Commissioners said they want to see if the COVID-19 case numbers are going up or down, then they will revisit that possibility.
