- 5. Discussion of budget concerning the upcoming Fiscal Year 2020-2021. Earls: I recommend that we go 3 months of salary out of our highway districts. Then voting again after the 3 months to pull it back out of county general. We will just monitor that and go from there. I spoke with Bill Turner, he said the first 6 months of the fiscal year will be a little bleak and the last 6 months will rebound. He is recommending that we set the budget at 90 percent of anticipated revenues like we always have and he thinks it will all level out for the entire year. Masterson: Whenever we buy fuel for our machines to put in our bulk tanks, we've watched the prices go down. That saves us money, buying it at a cheap price and storing it. I don't know how long that will last but it is a savings on our part when that happens. Earls: Our revenues are mostly collected from the sale of fuels and it doesn't matter what the price is, we get a portion per gallon. When it's cheap, with the exception of the pandemic, people will buy more fuel and that helps us. We get more tax revenue and the fuel we buy is cheaper. Mitchell: I would like to remind everyone that the budget reports are due by May 18th.

Earls: Would you like 12" and 6" both included on the bid? Furnas: Yes. The 12"holes don't work on rocky areas. Earls: It will be more expensive if we just use 6" and we don't always use those. Furnas: Information for the Ottawa County Health Department. They wanted to stress the fact that you don't have to have symptoms to get tested. You can call them at 918-540-2481, then dial 0, to make an appointment for the afternoon. It is curbside testing on Elm Street. It is important for us to get all of the testing that we can to get a valid study and results on where we stand with the virus. The more numbers we can get in to the samplings, it will give us a better understanding of where we are and it is at zero cost. The current numbers can be found on the health website. You can contact Sean Bridges at seanb@health.ok.gov with questions. They have teams that go into the long-term care facilities and they are doing everything that they can for them and the county. Thanks to the Quapaw Services Authority. We've been doing a lot of work with them and they've been a great partner to us. Normal maintenance. District #2: We took advantage of the nice weather last week and we hauled rock and clay and worked on a lot of roads. The latest number I heard on the COVID-19 was 34 and one death. We need to start thinking about having our meetings back in the courthouse even if we are separated. Just something to think about and maybe get things back to normal. But I would like to see these numbers being flat or going down before we do that. Routine maintenance. District #3: I agree Mr. Chairman. Routine maintenance. This morning we poured the head guardrail walls on bridge 137, the bridge that we lost 4 weeks ago. We are planning to pour the floor on Wednesday and hoping to have it back open next week, minus the guardrail and striping. One of the legislative ideas is visiting with Mike Mazzie, the Secretary of Finance, in our meeting and the State of Oklahoma and different legislators. We are trying to convert 35% of our served money going into our M&O for a period of time, whether it is just for the fiscal year or whatever. Then I heard from State Representative Boring this morning, they are not looking at taking any of our CERT money this year. That allows us to take our salaries out of the highway departments instead of the general account.
