1. The Ottawa County Board of Commissioners held their regular scheduled meeting at 9:00 A.M. on January 28, 2019, with the following members present: Chairman Chad Masterson, Commissioners Russell Earls and Mike Furnas. District Attorney Kenny Wright was also in attendance.

2. The Pledge of Allegiance was recited.
