5. Verna Ferris, Election Board Secretary, addressed the Board. Ferris: Last week we went to a workshop in Oklahoma City and every session was about security. A man from Homeland Security will be come be by in 2 weeks to inspect our office. When we came back from the workshop, the next day a man without any identification was in our data room. We don't know why he was there or who he was. It threw up a big red flag for me. My suggestion is, if it is possible, that all of our data lines be run into our office in our secure storage and I realize that it is going to cost money. But in my special depository account I have filing fees that I can use if the State approves it. And I think they will for security reasons. Can I just ask about it today or does it need to be put on the agenda to be voted on? Earls: I think it should be put on the agenda and voted on. Ferris: Even though my office already has the funds to pay for it? Earls: I think so. Earls: Do you have any idea what it is going to cost? Ferris: No, I don't but I can

make a phone call this afternoon and get an estimate. Earls: Do you have a lot of money in this account? It sounds expensive. Ferris: What is expensive? Earls: Around \$15,000 to \$16,000. Ferris: I don't have that much but it is close. I will try to have some money information for you.
