There is also a pet rescue in place which includes large animals and can also perform non-emergency roles, such as cleaning up properties, traffic control, etc. The State is pushing for a Teen CERT program that exposes teens to volunteering training early and provides a sense of self-awareness and ownership. The majority of the CERT Team funding could come from Emergency Management Performance Grant (EMPG) Grant, apply for a 501c(3) or a combination of those. The EMPG grant is about \$5000 per quarter.
