Kenny Wright, District Attorney, was also in attendance.

- 5. Concerned citizen, Darren Shepherd, spoke about the new Dollar General that they are going to build across from his house on E SW. His concern is that if they change elevation, it will change the water flow and cause flooding and also lower his home value. Kelly Shepherd, also a concerned citizen, said she called the corporate office and they said that their house is in the flood plain more than the store and they will keep it in code and begin building in less than a month. The Shepherds submitted a copy of the flood plain map and phone numbers for Dollar General to the Commissioners. Masterson: This is the first I have heard of it. Earls: If they build, they have to build 2 feet above base flood elevation. They can comply but they have to prove and have certificates that show they won't cause any flooding with the building they will do.

Shepard: Even right now the water will overflow in their driveway over E street into the ditch where they are building. Furnas: They have to have a zero-rise certificate and that takes an engineering stamp. Shepherd: They had this happen in Sand Springs and they took up a petition to get it stopped. Earls: Did they stop it? Shepherd: Yes, they did. And that's what we need to be doing. I can't believe that a business can come out and build wherever they want to without notifying the County Commissioners. Earls: We don't have any planning and zoning and that's an issue. I sit on the Resolutions Committee and I bring that up every year to see if that group is interested in looking at that. And every year they are not. I will ask legal counsel to look into adjacent property owners. We will follow up on this. They have to prove that it won't cause further or more flooding.

- 6. Motion by Earls, second by Furnas, to approve request by David Cline updating the Board of Commissioners on the progress of interactive media in the courtrooms. Cline: The matrix is out so we replaced the bulb. The immigration system where all of the inputs come in is so outdated and it's going to cost \$4000 to \$5000 if we can find the part for it. Kenny Wright: I think a large screen interactive with some blue tooth or wi-fi compatibility is probably the direction to go. I don't see too many courtrooms going that way yet but it is going to happen. Earls: Do we have that capability here now? Cline: York has a person on site. He will come and do a walk through and see what we need and the cost. By vote: Masterson, aye; Earls, aye; Furnas, aye.

Kathy Bowling, County Treasurer, presented the General Ledger showing the current balance. Becky Smith, County Assessor, reported that she received her final audit score from the performance audit from the Oklahoma Tax Commission. They needed a 192 to pass and they scored a 250. - 12. Motion by Earls, second by Masterson, to approve easement in District 1. NRCS (Natural Resources Conservation Service) is wanting signatures to encroach on the property. This is needed to show that we possess the legal right for entry onto this property to do the work that needs to be done. Masterson stated that he has an encroachment easement from Mr. Winscott to get in and do the work needed to the waterway and to the bridge at 16350 South Cayuga Road. This will help District 2 out tremendously. This amounts to \$86,536.00. By vote: Masterson, aye; Earls, aye; Furnas, aye.
- 13. Commissioners Activity Reports. District #1: I made an oversight last week in not congratulating the Courthouse who helped with FEMA. It was tedious and would not have happened if not for all of the work done here in the Courthouse. District #2: We are taking advantage of the warm weather to fix roads damaged last week from the 2" of rain. Routine maintenance. District #3: We started on FEMA work. Chad Holcomb and Ed Crone and I attended a meeting in Tulsa to better understand the CDBGDR money. Department of Commerce struggles to administer this money, due to authorization of new dollars and the changing of rules each time. But we are going to try to work through this and with them to try to tap into some of this money. Routine maintenance.
- 14. Earls stated the they have been working on the new roof of the jail with the contractor. Talked to Dan Cook and the Sheriff today. They indicated that it seems to be dry after the rain that we had. Also, working with Johnson Controls to try to get the control system that manages the sprinkler heads and smoke detectors fully operational to get the green tag. The Sheriff indicated that they are going to push really hard to get the prisoners back this week. It will be a long process because when the prisoners get back, we will continue to work pod by pod. Furnas said they will find out tomorrow at 3:00 about a bidding opportunity. There has been a need to replace the stove and convection oven. We will

find out if we are successful in the bid to at least replace the gas range, grill and oven. The cheapest we found is nearly \$3,000 for a convection oven.
