In another item, David Cline, County Maintenance, stated that he would like to finish out the District Attorney's office with LED lighting. He has spent \$560.00 for a portion of it but would like to finish the rest for \$2,000. Earls said it should be done in small portions to alleviate paying such a large amount up front.

16. Commissioners' activity reports: District #1: We made sure that the bridges and overpasses were safe during the snow storm. I went to a conference in Norman and they asked us to keep an eye on bills that are being proposed which will concern each of us. The census is coming out and I would like to encourage everyone to take part of that. Normal maintenance. District #2: First part of the week, we were getting ready for the storm, the middle of the week we were spreading salt and getting snow off of the road. Hopefully this week we will be able to haul rock and do some maintenance. Routine maintenance. District #3: We also dealt with the winter storm. Routine maintenance and FEMA remediation.

17. Earls reported that they are down to working on the fire suppression system at the jail. Keeping in constant contact with Nick at Johnson Controls. Got the plans for the jail from the designers in 1997. It didn't have a complete set of schematics for the fire suppression system so Nick is drawing that out because the system is polluted with rust and hard water that has set in these lines maybe since it was built. So, they are taking steps to try to clean the system up and get it functional before they fire it up and pollute the valves they've just recently replaced. There are 14 prisoners over there and we are working with the fire department to have some type of special evacuation. They do a 15-minute fire watch on the rounds.
