District Attorney Kenny Wright said he visited with the Sheriff and he has all of the original titles for all of the vehicles and is getting ready to move forward. 15. Commissioners' activity reports: District 1: Congratulations to Summer Aldridge for passing the Flood Plain Management course. Salted and sanded overpasses. Working on tin whistles, burrowing beavers opening up underneath roads. Routine maintenance. District 2: Spread salt, maintenance on vehicles, routine maintenance. District 3: Routine maintenance. Attended CODA (County Officers and Deputies Association) conference last week and went to the Sheriffs and Commissioners breakout. Would like to explore the possibility of a trust in the jail. It puts a layer of protection between the County government and the Sheriff's department. There are deficiencies and better oversight with a trust. I will be visiting with other Counties that already have trusts in place. Cherokee County has a trust and it's been very efficient. They actually have to keep County government and the trust at arm's length. They hire your office to do payroll. That is something I would like to explore and report back to this Board, see if it is worth our while to head down that avenue. It seems like it is a layer of protection and there are more and more Counties going this direction. Wright replied, "I think we will eventually see all Counties going this way. Our last big District Attorney's meeting, that was one of our big topics. There are many types of trusts, there are a couple of statutory forms for it, and you can tailor it to individual local needs. I agree that it would be something that would be good for the County. There's some

difficulties with the sales tax and how that would be split up but that would be worked on later." Earls continued, "They continued to talk about training and supervision. Across the State we see deputies that continue to have a record of really rough arrests with very little to no supervision. That's where training comes in as well as if you have documentation on deputies, you need to have somebody who is working with these deputies on first offense, second offense, then on the third you are out. Then the wrecks are draining our pool, we are self-insured, and we all share the risks state-wide. It is the only way we are able to have insurance. If we had to get insurance in the private sector, I don't think we could do it. When the County has a bad year, we all share in that and that is how we survive. One of the things we get in trouble with in the jail is if you have blind spots, and the inmates know if it. It's very important to have any areas, other than private areas, there needs to be cameras every place we can put them. A law firm talked about a game among female prisoners to get a jailer to have sex with them. One of the obvious reasons is for law suits, but they are trying to defend this and that is to have body cameras on the jailers as they interact with prisoners and to have two guards at all times. If there is any interaction with a female prisoner there needs to be two guards and a body cam. They have seen allegations across the State and probably actions have been taken that were improper. Body cameras are very important. The other thing is there is an app that is not that expensive, that can be put on the deputy's cars. The Sheriff, DA, or whoever, can see what these cars are doing any time, can see what speeds they are running, see if they have been sitting idle for two hours, just know exactly what they are doing. It is pretty inexpensive to have this, it's like having a supervisor in the car at all times. I think that is something we should also look at. The TPA on the Turn Key, we've all seen what that costs, in training they continue to stress how important it is to have a third-party administrator, what they are telling us is you don't want a Sheriff or a deputy making calls on medical. If an inmate is sick, you don't want them saying 'Oh he's fine, he's faking it'. You need trained people that are doing this. It is something we are going to have to continue to discuss and look at. Part of me says we can't afford it and the other part says we can, thinking about lawsuits. That is something we are really going to have to look at hard. Mostly, I think we need to stay with this and implement what is good for the County."
