March 16, 2020

The Ottawa County Board of Commissioners held their regular meeting at 9:00 A.M. on March 16, 2020, with the following members present: Chairman Chad Masterson, Commissioners Russell Earls, Mike Furnas and County Clerk Robyn Mitchell. Kenny Wright, District Attorney, was also in attendance.

2. The Pledge of Allegiance was recited.

3. Motion by Earls, second by Furnas, to approve minutes from March 9, 2020. By vote: Masterson, aye; Earls, aye; Furnas, aye.

5. Citizen D'ann Mathia asked the Commissioners what the policy is with the County concerning the Coronavirus. Masterson said they are going to meet this afternoon.

6. Discussion with public citizens and the BOCC concerning access to the completed audit of the Sheriff's office. Robyn Mitchell, County Clerk, stated the report is completed, and waiting to be reviewed by State Auditor, Cyndi Byrd.

7. Discussion with public citizens and the BOCC about anticipated actions in regard to results of special investigative audit. The BOCC response: We will not discuss actions until we are presented with the report.

8. Discussion with public citizens and the BOCC concerning funding for the Investigative Audit on the Sheriff's department. Earls stated that will be discussed later.

9. Discussion with public citizens and the BOCC concerning conduct during meetings of elected officials. Earls expects everyone to conduct themselves like they were in a court room.

10. Discussion with public citizens and the BOCC concerning the current budget status of each departments average spending, and unexpected expenses. Mitchell stated that every elected official's department stays within their budget, except the Sheriff.

11. D'ann Mathia presented a list of road conditions from public citizens. The Commissioners suggested that the citizens call their district's office with these concerns. They are available 24 hours a day, 7 days a week, to discuss the issues they are having.

12. Discussion with D'ann Mathia, and Jay Calan concerning funding of District Attorney's office by the County. Wright stated that \$5,000 is for books and the \$40,000 is for personnel to represent Ottawa County.

13. D'ann Mathia asked the Board about the increases in theft, etc. and the lack of prosecution for these issues. DA Kenny Wright believes it is due to the state passing of 780 and 781, and stated the reopening of the jail will make a difference. The Tribes play an important role for Ottawa County and will continue to do so.

14. Motion by Earls, second by Masterson, to approve invoices from Delaware County Sheriff's Office for the housing of inmates in the amount of \$5,481.30 and inmate transport from Florida in the amount of \$621.01. By vote: Masterson, aye; Earls, aye; Furnas, aye.

15. Motion by Earls, second by Furnas, to approve invoice from Tulsa County for housing inmates in the amount of \$40,000.00, still owing the \$36,245.00. By vote: Masterson, aye; Earls, aye; Furnas, aye.

18. Darla Thompson from the Ottawa County Health Department discussed the Coronavirus. Information packets were handed out on the virus and information was given on what the symptoms are, and how to try to avoid exposure and passing it to others.

19. Motion by Earls, second by Furnas, to approve Modification of Contract number A16AC00032 from Bureau of Indian Affairs for the State Line Road, in District #2. By vote: Masterson, aye; Earls, aye; Furnas, aye.

20. Motion by Masterson, second by Earls, to approve an Emergency and Transportation Revolving fund loan application and agreement for various small bridge locations in Districts 1, 2 and 3. By vote: Masterson, aye; Earls, aye; Furnas, aye.

21. Motion by Furnas, second by Earls, to approve Project Number G04927-0160(1) G, S payment of \$191,420.01 for the Stateline Road project. By vote: Masterson, aye; Earls, aye; Furnas, aye.

24. Motion by Masterson, second by Furnas, to approve the following cash for deposit in the amount of \$100 from American Zinga, because of their refusal to clean the community room after use. By vote: Masterson, aye; Earls, aye; Furnas, aye.

28. Commissioners' activity reports. District #1: There have been more problems with old structures and some of them need to be replaced. Working with FEMA and trying to get reimbursed on funding that was lost last year. We are focusing on Promenade Bridge and asking for help to keep it stable before it can be repaired properly. District #2: Thanks to District #1 for helping put in a cross drain on 500 road. Concrete for bridge on 128 Road is done. Stateline Road is also coming along nicely. Last week we hauled rock to problem areas and did road work. Routine maintenance. District #3: Routine maintenance and FEMA remediation. We hauled all of the trash off of Sally port at the jail. It is greentagged, inspected and ready to go. I recommend we pay the VISA that was discussed last week, which the County will pay the interest total of \$68. The unauthorized amount of \$149 is the Sheriff's personal part, and should be paid by him.

29. In new business, Earls discussed with Cornell Cross to start putting together a plan for cyber security in the courthouse. A bid will be put together for this. Also, it is recommended that a committee be formed to investigate the Coronavirus as far as how to clean the court rooms while court is in session, the Courthouse, Annex building and jail. Masterson said he would like for there to be a committee put together to address this.
