- 1. The Ottawa County Board of Commissioners held their regular scheduled meeting at 9:00 A.M. on March 18, 2019, with the following members present: Chairman Chad Masterson, Commissioners Russell Earls and Mike Furnas. District Attorney, Kenny Wright, was also in attendance.

- 6. Motion by Earls, second by Furnas, to approve District #2's purchase of 2.9 acres of land directly North of existing County Warehouse located in Wyandotte. Adjoins Grand River Dam Authority and is next to the school. Masterson said this is for the safety of the equipment. By vote: Masterson, aye; Furnas, aye; Earls, aye.
- 7. Motion by Earls, second by Furnas, to approve Allocation of Alcoholic Beverage Tax from County Treasurer. By vote: Masterson, aye; Furnas, aye; Earls, aye.
- 10. Motion by Earls, second by Furnas, to approve the following check (s) for deposit: #1029 from Eli Chenoweth for \$800.00; #18395 from American Fidelity for \$105.00. By vote: Masterson, aye; Furnas, aye; Earls, aye.
- 11. Summer Aldridge, Emergency Management, said the flood plain maps will be effective March 19. We have 6 months to get them into effect for the County. This will be emailed to Board of Commissioners and Kenny Wright for review or any updates and will be put on the agenda for next week. Also, Geospiza developed a vulnerability software called Swift. It would have an annual rate of \$2,500 and could be split with the City of Miami if they decide to take part in the program.
- 13. Commissioners Activity Reports: District #1: All 3 districts helped with the demolition of houses. Today we assisted with the city wide clean up. Routine maintenance. District #2: Getting the roads back in shape from the bad weather we had a couple of weeks ago. Building a bridge with District #3 on 705 road. Also, the auction for the Sheriff's department vehicles is coming up on Saturday the 23rd at 10 a.m. at 808 H SE. Routine maintenance. District #3: Thursday there was an emergency meeting at Grand Gateway to approve a \$50,000 REAP (Rural Economic Action Plan) grant for Nowata County. Their prisoners were moved out of the basement at the court house due to strange gases and there are no fire alarms. This grant will allow them to get these issues addressed and hopefully the prisoners back to the jail. Delaware County received a \$6,700 grant for a generator. Also, there will be a kick off meeting next Monday for the Route 66 project. National Parks is partnering with us on the project. This is County road beginning one mile south of State Highway 125, East West 120, then one mile west on East West 130,

then one mile south North South 540. Then County road North South 520 from US 69, then two miles east, one mile to US 69. This is a two-phase project. Routine maintenance. April 6 there will be a County wide clean up at the facility. April 9 there will be one in Fairland and April 10 in Afton. Co-op with local FFA's and they will load the front-end loaders.

- 14. Motion by Masterson, second by Furnas, to approve a letter submitted by Earls, a letter of support asking for the Ottawa County Government to be the co-author of a \$3,000,000 grant for Highway 69A from the BNSF railroad north to East 66 Road. A tribal center is going to be built and J&M Farms is expanding, creating 100 jobs, so there is a lot going on over there. This is in conjunction with the renovation of the Steve Owens intersection from I-44 Turnpike. Kansas is making Highway 69 a four lane, so this will tie in with this renovation project. By vote: Masterson, aye; Furnas, aye; Earls, aye. Earls also stated that Commissioners across the state participated at the Capital for transportation day along with TRUST (Transportation Revenues Used Strictly for Transportation). HB 2676 sponsored by Representative Kevin Wallace will put \$30,000,000 back into the CIRB (County Improvement Roads and Bridges). Three years prior, the Legislature has taken \$230,000,000 out of CIRB accounts because of their shortfalls. We have been pushing them to restore that fund. The Governor is on board with this so it looks favorable for us to get the thirty million back. But we will ask for all of it back as time goes on, if they have the revenue.
