Also trying to get some masks out to people working on the school food program. District #2: We've been working on problem areas also. The weather had dried up enough by the end of the week where we could get some roads back up in shape to get some better drainage on them. I just want to emphasize that we can't be too careful with COVID-19. Everything we do is in the safety of our

employees and the public. We tried to order more masks and they are not to be found. We did order some gloves and distributed them to the Emergency Manager. Routine maintenance. District #3: We are conducting FEMA sight inspections and FEMA remediation. Routine maintenance. I just want to caution everyone to stay safe and I encourage you to wear gloves and masks if you can.
