- In discussion regarding sheriff's request for additional funding for fiscal year 2017-2018, 14. Commissioner Earls stated he went over the issues with the sheriff last week. Treasurer, Cathy Bowling, stated she had spoken to CPA Bill Turner and that an early apportionment could be done after June 25 deposits. Commissioner Earls stated there may not be any money come in by June 25 so we should approve what he needs for this fiscal year and lower his estimate of needs for next year by that amount. Sheriff stated that DOC is behind several months and wants to know what would happen if the money comes in after June 25. Treasurer Bowling stated that it would then go on next years fund. Commissioner Clarke asks if any money that comes in between now and June 25 would be transferred to 2017-18. Treasurer answered yes. Commissioner Earls stated the money may or may not come in. Treasurer Bowling asked if a transfer could be done for just what is needed today and wait until the 25th to do the rest. Commissioner Earls stated yes and asked Tasha (Natasha Mays, Purchasing Agent) what her thoughts were on that. Purchasing Agent Mays stated we don't want to wait too long to pay the bills, that the purchase orders have to be encumbered by the 28th. Mays stated she would just do transfers now to make sure he's covered and get things paid. Commissioner Earls agreed.
