- 6. Motion by Masterson, second by Furnas, on Bid 2019-2020.09 on Hydraulic Excavator received from Fabick Cat and The Victor L. Phillips Company tabled from August 19, 2019. Victor L. Phillips Company was chosen because of more options and features. By vote: Masterson, aye; Earls, aye; Furnas, aye.
- 7. No action for a sporting complex located on the County farm until a lease is drawn up. Masterson: Who is going to maintain the facility? Zeb Neece: What our proposal is to have an anchor tenant or have someone in there that would have their own business and that person could be the facilitator. The Board that has been created will oversee to make sure the fields and maintenance are taken care of. But our goal is to have someone on site all of the time. Masterson: And they will mark the fields? Neece: Yes. We are not looking for the County or City to maintain. Earls: Would it be more beneficial for the County to maintain ownership for grants purposes? Neece: I believe so. I think our goal would be to have a one hundred twenty- five year lease where we have the rights to build and develop. I do think there are advantages for it to be County owned. I may be wrong about that but that's something that will be discussed. Furnas: Counsel, are there any liabilities that come along with this? Wright: There's always a liability. We will have to look closer at the business plan. There are certain activities that would be included as long as it's County owned property. That's something we will just have to look at in more detail when the time is right.

This is a project in District #2 along with the Bureau of Indian Affairs. They had to lower the drives going into the cemetery on the Missouri side. By vote: Masterson, aye; Earls, aye; Furnas, aye.

Sheriff: This is for legal concerns that I have and it is going to be up to the Board to approve it. Earls: Are you able to elaborate? Sheriff: Not at this time. Earls: Counselor, without any information, should we have an executive session on this? Wright: We did not have an agenda for it so we can't do that. I am aware of the purpose for requesting counsel and I do think it is appropriate, but it's a little difficult for the Commission to make a decision without knowing what it is for. Any ideas Jeremy? Sheriff: Just guidance and legal advice that I'm probably going to take outside the County. Earls: I would rather have some information from either you or the Sheriff, even if it

is in private, or schedule it next week in Executive Session before I make a decision. Wright: Sheriff, why don't we try to get together and visit on it and see how you want to go forward with it. Mitchell: They can't make a decision unless they are in a meeting, so do you want me to put this on next week's agenda, Sheriff? Sheriff: Yes.
