
**WHEREAS**, the Board determined it is in the best interest of Ottawa County to have an updated resolution on file for citizens to review and obtain copies as necessary, and






WE, THE BOARD OF COUNTY COMMISSIONERS OF OTTAWA COUNTY,  
OKLAHOMA, HEREBY SOLEMNLY SWEAR AND AFFIRM AS FOLLOWS:


1. That we are the Board of County Commissioners in and for Ottawa County, Oklahoma.
